AFFIDAVIT

FATHER DAVID A. HOLLEY, being duly sworn and upon oath,
states:

1. I am a Defendant in the above-referenced case. I have
defaulted in the case as I have no non-exempt assets, no lawyer,
and I am currently in jail. However, I have been asked to
provide an Affidavit regarding my relationship with the Diocese
of Worcester while I was at Servants of the Paraclete, and I have
agreed to provide this Affidavit containing my sworn testimony.

2. I was born on August 2, 1927, and ordained as a Roman
Catholic priest of the Benedictine Order on May 31, 1958.

3. On May 11, 1962, I sought appointment as a diocesan
priest of the Diocese of Worcester, Massachusetts, making this
request of Bishop Bernard Flanagan. Exhibit A. This request

required the permission of the Benedictines and of the Diocese of Worcester. On July 16, 1962, Bishop Flanagan notified me and my Abbot that the Diocese of Worcester was accepting me for three (3) years on an experimental basis. Exhibits B and C. On October 31, 1962, I was appointed by the Diocese of Worcester as assistant pastor at St. Philip's parish in Grafton, Massachusetts, Exhibit D, and then to St. Mary of the Hills parish in Boylston, Massachusetts. Exhibit E. In 1967, the Bishop of Worcester transferred me to Our Lady of Fatima parish in Worcester. Exhibit F. On May 15, 1967, I was officially incardinated to the Diocese of Worcester. Exhibit G. By becoming incardinated to the Diocese of Worcester, I took a vow of obedience to the Bishop of Worcester, agreeing to do as he directed, and I was released from my vow of obedience to my Superior in the Benedictines.

4. My psycho-sexual disorder first began to manifest itself in approximately 1962.

5. Before I became officially incardinated to the Diocese of Worcester, Bishop Flanagan had received reports that I had sexually molested boys in the above-referenced parishes. On at least two occasions Bishop Flanagan called me in to discuss the allegations, cautioned me against causing a scandal in the church, but he expressed no comments about my victims. He said that my actions were a cause of scandal to the Diocese of Worcester.

6. On August 17, 1968, after my incardination, Bishop Flanagan wrote to Father Jerome Hayden, a priest-psychiatrist,

informing Father Hayden that I had sexually molested boys in the Diocese of Worcester and placing me in Father Hayden's care for treatment. Exhibit H. A month later, Bishop Flanagan appointed me to be assistant pastor at St. Anne's parish in Southboro, Massachusetts. Exhibit I. There were no restrictions on my faculties that I recall, and I was concerned that I was again being given access to boys.

7. In 1969, I requested that Bishop Flanagan allow me to be admitted to the Seton Psychiatric Institute for treatment of a psycho-sexual disorder. The Bishop agreed, and I was admitted there, but retained some of my priestly faculties. I also remained under the control of the Bishop. For example, on May 6, 1970, the Bishop gave me permission to attend and officiate at my brother's wedding. Exhibits J and K. In March of 1970, Bishop Flanagan informed me that he would not rule out the possibility of my returning to parish work in the Worcester Diocese. Exhibit L.

8. In December of 1970, I was discharged from Seton, and the doctors issued a report to the Bishop. Exhibit M. Around that time, my full faculties were restored, but I was unable to get a parish assignment from Bishop Flanagan although I requested one several times. Bishop Flanagan informed me that he would attempt to secure a parish assignment for me outside of the Worcester Diocese. Other Dioceses, however, including the Diocese of Wilmington, Delaware, and the Archdiocese of Boston, Massachusetts, refused to accept me because of my psycho-sexual disorder. Thereafter, Bishop Flanagan told me he wanted me to go

to Servants of the Paraclete in New Mexico. On March 23, 1971, I wrote to the Bishop telling him I would prefer to stay at a Paraclete house in the East, like their Vermont facility, but that I would do as he wished when he made the arrangements.

Exhibit N.

9. In September of 1971, Bishop Flanagan sent me to New Mexico, and informed Servants of the Paraclete that the Diocese of Worcester would be responsible for my care and treatment.

Exhibit O. I was ordered by Bishop Flanagan to leave the State of Massachusetts and enter the program in New Mexico. Bishop Flanagan also directed me by letter to go to New Mexico, and he sent me plane fare, on October 1, 1971. Exhibit P. I went to New Mexico reluctantly and against my wishes, but out of obedience and pursuant to the orders of my Bishop. It was clear to me that Bishop Flanagan was fearful that if I stayed in Massachusetts I would repeat the acts for which I had been in treatment, and that this would, in turn, cause further scandal in the Diocese.

10. Prior to leaving for New Mexico, Bishop Flanagan lifted all restrictions upon my priestly faculties since I would need faculties to assist the Servants of the Paraclete in local ministry. Once again, therefore, I had unrestricted faculties as a priest of the Worcester Diocese. Bishop Flanagan instructed me to notify Father Joseph McNamara, a Paraclete official, of the time of my arrival in New Mexico, and the Bishop informed me that

Father McNamara would direct someone to meet me at the airport.

Exhibit P.

11. When I arrived in New Mexico, Servants of the Paraclete placed me in a house on Pajarito Road in Albuquerque where I remained for almost exactly one (1) year. I was never taken to the Jemez Springs facility. I was never given a psychiatric or psychological evaluation, or a spiritual evaluation. No history of my problem was taken. I participated in no therapy or treatment programs offered by Paraclete. I never met with a Paraclete psychiatrist or psychologist. I was simply told by the Superior at the Pajarito Road facility to see Dr. Donald Cummings at Lovelace once a week. The Diocese of Worcester received and paid bills for my treatment, Exhibits Q and R, I sent reports on my conduct to Bishop Flanagan, Exhibits S and T, and he sent letters to me, Exhibit U. Almost immediately after I arrived at Paraclete, I was given parish assignments for week-end work in the South Valley of Albuquerque. The Bishop of Worcester gave me faculties to do this work and knew I was doing it. Additionally, I believe Paraclete obtained faculties for me from the Archdiocese of Santa Fe since I performed all the holy sacraments in these Albuquerque churches. The Santa Fe Archdiocese could not have permitted me to perform the holy sacraments in New Mexico without seeking and receiving permission from the Diocese of Worcester and the Diocese of Worcester's confirmation that I was in good standing there.

12. The Diocese of Worcester supported me financially while I was in New Mexico, and I regularly performed work for the

Diocese of Worcester, as directed by the Bishop of Worcester, while I was in New Mexico. For example, on December 27, 1972, the Bishop of Worcester wrote to me transmitting money for my dental bills and transmitting Mass stipends money for twenty-five (25) Masses. Exhibit V. The Bishop directed me to say the twenty-five (25) Masses for parishioners of the Worcester Diocese which I did in the chapel at Paraclete on Pajarito Road. To explain further:

- A. People in the Worcester Diocese would send in donations - usually \$3.00 to \$5.00 - for Masses to be said for a loved one. The people asked that a Mass be said to express their intentions to God for the well-being of a loved one, for example. However, Worcester is a small diocese, and the priests there could not accommodate all the Mass intentions.
- B. Therefore, Bishop Flanagan sent the donations and prayer requests to me in New Mexico with instructions that I, as a priest of the Worcester Diocese, pray for the Worcester parishioners by saying Masses for them in New Mexico to fulfill their spiritual intentions.
- C. While in New Mexico, I regularly said Masses for Worcester Catholics pursuant to Bishop Flanagan's instructions, his transmittal of the Mass stipends and his transmittal of the Mass intentions.
- D. I could not have said Masses in New Mexico for Worcester Catholics at the direction of the Bishop of Worcester without faculties from and direction by the Bishop of Worcester.

13. The Diocese of Worcester also sought and received reports on my treatment in New Mexico. Exhibits W and X.

14. At all times that I was in New Mexico, I was a priest of the Diocese of Worcester, acting for, on behalf of, and in accordance with my vow of obedience to the Bishop of Worcester. The Bishop of Worcester told me what to do, or gave me permission to do certain things, and I did them.

15. I started working in Alamogordo in 1972, and I went there with the permission of the Bishop of Worcester. While the Diocese of Worcester did not directly receive financial benefit from my service in Alamogordo, it received a benefit it very much wanted; namely, my absence from the Worcester Diocese and the resultant abatement of the scandal my behavior had caused. The Bishop of Worcester permitted me to go to Alamogordo so as to achieve that benefit for the Worcester Diocese. My faculties from the Diocese of Worcester remained intact while I was in Alamogordo, and the Diocese of El Paso also granted faculties to me at the request of Father Wilfred Diamond, a priest of the El Paso Diocese. The El Paso Diocese could not have permitted me to perform the holy sacraments in New Mexico without seeking and receiving permission from the Diocese of Worcester and the Diocese of Worcester's confirmation that I was in good standing there.

16. No one, from the Worcester Diocese, including Bishop Flanagan, ever objected to the exercise of my faculties at any parish in New Mexico. In fact, Bishop Flanagan informed me that it was good to know that I was actively engaged in pastoral

ministry in New Mexico. Exhibit U. Therefore, there is no question that, in addition to requiring that I perform certain duties on behalf of Worcester parishioners, Bishop Flanagan was well aware of my parish work in New Mexico.

17. My absence from the Diocese also gave the Bishop an opportunity to determine what type of permanent assignment would be appropriate for me. On December 7, 1972, I wrote to Bishop Flanagan informing him that I was prepared to return to full-time ministry, and asking for a permanent assignment in the East. Exhibit V. On December 27, 1972, the Bishop responded to my request by informing me that he would need to contact my doctor and the Superior of the Paraclete House before he made any decisions about my future outside of New Mexico. Exhibit V.

18. In September of 1977, the Bishop of Worcester gave his consent to my temporary assignment in the Diocese of San Angelo, Texas. Exhibit Z.

19. In October of 1987, the Diocese of Worcester assured the Archdiocese of Denver that I was a priest in good standing of the Worcester Diocese. Exhibit AA.



Shortly before this lawsuit was filed in 1992, the Bishop of Worcester directed me to leave Denver and check into the St. Luke's Institute in Baltimore which I did since I remain a priest of the Worcester Diocese. Indeed, since I was incardinated to the Worcester Diocese in 1967, to the best of my knowledge I have never been excardinated from the Worcester

Diocese, nor has my laicization ever been sought, and I remain a priest of the Worcester Diocese to this day.





Your Excellency, Bishop Flanagan:

Permit me to introduce myself before I go on with this letter. I am Father Benet D. Holley, O.S.B., 34 years of age and ordained a priest for four years. Three years ago, while stationed at Glastonbury Latin School in Hingham, Mass., I first came in contact with Msgr. Joseph P. Burke who is now pastor of St. Patrick's in Lawrence, Mass. Last Christmas, while visiting my sister in Medway, I stopped to see Msgr. Burke and it is he who suggested that I write to you personally.

After frequent prayer to the Holy Ghost and advice from my spiritual director, it is my sincere desire to leave the religious life to become a diocesan priest. During the past three years, I have become increasingly aware that this is my place in God's vineyard. Your diocese, Bishop Flanagan, is where I would hope to achieve personal sanctification while serving God more effectively.

I have applied to no other diocese for admission as I earnestly desire to be installed in Worcester. In your diocese I know that I would be happy and do good work so I pray that you may find room for me. As I noted before, my married sister lives in Medway not too far from the diocesan boundary.

Several priests in the past few years have left our Abbey and become secularized. This has made the Abbot quite angry and is the reason why I hesitated to write sooner. If the Abbot learns of my intention to secularize, it is possible that he may send me to one of the Latin American missions as he has done to the other priests before they were released. Dear Father Hayden:

Within the next few days, I expect that you will receive a call from a 41 year old priest of this diocese whom I have advised to see you. I will be responsible for your professional service fees and any related expenses.

This man has been charged with molesting teen-age boys on at least two occasions—most recently in a hospital from which he has been barred—and with carrying around and showing to these boys pornographic magazines and books. Although the charges were established beyond any doubt in the judgment of the priests who assisted me in the investigation as well as myself, Father has denied any wrong doing. He continued to assert his innocence even in a confrontation with us and one of the boys—an 18 year old lad—who appeared at our request to detail the hospital incident.

I relate all this to point out that you may have some initial difficulty in getting this man to admit that he has a problem, even though he has readily agreed to see you. I did however repeatedly insist on his being completely open with you and can only hope that in a different set of conditions he will be less defensive and more truthful than he has been in his dealings with us.

Please know that I will be grateful for any help which you may be able to give this man. In due time, I would appreciate hearing of any progress you may also be able to report.

Your Excellency:

I am writing in reply to your request concerning Reverend David Holley's course of hospitalization.

Father Holley was admitted to this hospital on August 10, 1969, on a voluntary basis on the referral of Reverend James Hayden, M.D., who treated him for five months prior to his admission. His presenting problem was compulsion, rigid attitude and a repeated behavioral difficulty which caused conflicts with his parochial work. For quite some time during his hospitalization Father Holley was resistant to the therapeutic situation. He had great difficulty in recognizing his problems, and consequently in being motivated toward trying to do something about them. This arose out of his basic personality difficulty which makes it difficult for him to reveal himself to another person. However, during the course of therapy Father Holley did develop a positive relationship with his therapist which enabled him to gain insight into the nature of his difficulties, and along with this he seems to be motivated to do something to resolve them. While the change certainly gives some reason for optimism, it is important to note that this is only the beginning, and continued outside therapy is strongly indicated, as the treatment of this type of personality disorder is time consuming.

In summary, we feel that Father Holley has benefited some from therapy in the hospital. Continued therapy is recommended for growing insight and motivation in order to minimize the chances of any behavioral difficulties. Father Holley, has continued to express a strong desire to function as a priest.

happy around there but not in
diocese in the West.

Perhaps you have some influence with the Bishop of Norwich and could write a letter for me asking about working in his diocese at least on a trial basis. I feel this would be beneficial for me now as the stigma of being at Peter is bad enough and going to the Parole Fathers will make it more difficult.

Thank you again for your interest, Bishop. I will need some financial help to return to Medway to pack my baggage. As soon as you make the arrangements with the Parole Fathers, I will be happy to hear from you so that I can soon return to God's work.

I attach herewith a history of the priest, Father David Holley, whom you have kindly agree to receive at Via Coeli. I am contacting him today and directing him to notify you of the time of his arrival in Albuquerque--which should be within the next three or four days.

His past history would seem to give us little hope of his being able to resume an effective ministry for a long time, if ever.

I have no objections to his celebrating Mass as soon as your own norms for his privilege are satisfied.

We will be responsible for his care and treatment.

Sincerest best wishes now and always. I hope you are able to get through the winter in good health.

My visits to the Lovelace Clinic in Albuquerque have been very beneficial and I am grateful for the therapy from Dr. Cummings. I have worked in three local parishes on weekends and occasionally during the week.

With the approval of the doctor and the Paracletes, I have written to the Veterans Administration in Washington for information about a chaplaincy appointment. Since I am a thirty year veteran of the Navy, I made a visit to the local V.A. hospital and talked to the chaplain about this special apostolate. He encouraged me to write but thought there were no openings at present. I have done chaplain work in five different hospitals and find it to be very rewarding.

The Paracletes do not make any contacts for their guest priests. Their policy is to let the individual work out his own problem by prayer and with the help of his doctor. When the priest and the doctor agree that rehabilitation is complete, the priest himself seeks to get back to a suitable apostolate.

As I wrote before, the Paracletes are having their own personnel problems. The superior at Via Coeli has left the priesthood and rumors persist that the superior here at Pius XII Villa will be leaving soon.

The enclosed bill is for some dental work which I had done last month. I have three or four more visits scheduled this month and next. I am very grateful for your kind assistance in my time of need and humbly request your continued prayers for my return to the active ministry.

Prayful best wishes for the Easter season and the rest of the year. I hope that you are in good health and that the weather in New England soon improves. We are experiencing unusually warm weather in New Mexico.

Enclosed is the final bill from the dentist. The doctors of this area are not as generous toward the clergy as the ones in the East.

Starting tomorrow and through Easter, I will be assisting at one of the parishes which is a $5\frac{1}{2}$ hour bus ride away from Albuquerque. The parishioners here are deeply religious but extremely poor financially.

Since my last letter to you, I have heard from the Veterans Administration in Washington. There are no vacancies at present but they are retaining my application for a chaplaincy for future consideration. When an opening occurs, they will contact you for permission to start the procedures and then forward the application to Msgr. Joseph Marbach, the Chancellor to the Military Ordinariate in New York for official endorsement.

Dr. Cummings at the Lovelace Clinic and the new superior at Pius XII Villa both approve my desire to work in this apostolate. There was only one question about medical history on the application which I showed to Dr. Cummings. He said that the question did not affect me and there was no need to volunteer information about my past problem.

In regard to my present status, I wrote that I am on a special assignment outside the diocese working as an assistant. I was advised to do this by the chaplain at the local V.A. hospital. He also said that a letter from a Senator or Congressman to the V.A. would be very influential but I have been out of the state for quite some time now.

I am most eager to return to full active duty as soon as possible and can finally say that I have conquered the tragedy that has plagued me in the past. If I do not hear from the V.A. in a reasonable time, I may apply once more to the Boston Archdiocese for an assignment since the Worcester Diocese is closed to me.

Your prayers are humbly requested, dear Bishop, that I may soon return to full time service to God and His Church. Thank you for your charity and understanding of a priest in need.

It was a year in October that I arrived in Albuquerque and I have been visiting Dr. Cummings at the Lovelace Clinic almost weekly. I am grateful to God for his many blessings and the counseling I have received at the Clinic which has prepared me to return fulltime to the active ministry. Today, I will be leaving for St. Jude's in Alamogordo to assist through the holidays.

The Veterans Administration has written three times saying that my name was on the eligible list for a chaplaincy but that the turnover rate was extremely slow. I have almost given up hope of receiving an assignment. The Paracletes are continuing to suffer from a personnel shortage so I can get no assistance from them. Fr. Joseph McNamara, the Paraclete General, has been filling in as Superior in their house at Canton, Ohio for the past few months.

I would be grateful, dear Bishop, for your personal advice and help in receiving a permanent assignment. You have my consent to receive him into the Diocese of San Angelo on his return and to give him an assignment.


