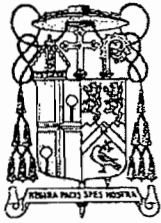



It would also mean a lot to me to have another friar along.

ORDINATION TO FRANCISCAN ORDER

GARY PACHECO, O.F.M.

Gary was born to parents of Portuguese decent in Honolulu, where he attended public schools and graduated from McKinley School there in 1965.

Since there are no Franciscans in Hawaii, people wonder how he came associated with the Friars: His family traveled quite often to California where they stayed with relatives in St. Elizabeth's parish, and there he made contact with the Franciscans. After graduating from high school, and moving into St. Elizabeth's parish, he attended Merritt Junior College, and from there to Cal State.

During his college studies he was torn between what he was doing and his attraction to the priesthood. In 1968, he made up his mind to enter the priesthood in the spirit of St. Francis, applied and was accepted to enter the Novitiate in 1969.

After one year in Sacramento, he began his theology studies in Berkeley and was ordained a deacon in October of 1973, when he was sent to Oregon for 6 months, and then back to Berkeley for the last school quarter.

Following ordination, he has asked to return to Oregon, to pursue his fields of interest in parish work and vocation promotion.

Gary will be ordained to the priesthood on May 25 in Santa Barbara and will offer a Mass of Thanksgiving at St. Elizabeth's church on Sunday June 9 at 12:15 pm.

After talking with [redacted] about where I will be stationed after ordination, I did a lot of thinking about it. To be honest, I was very surprised that Fresno was even being considered for me. My reasons being: 1) I am not Mexican. 2) I do not speak or understand a word of Spanish. 3) I would not know the culture or background of the group of people that would make up the majority of the parish. I do not feel that I could do justice to the people I would be expected to serve and I would be very uncomfortable in that situation. I spoke to Fr. Alan about it and he can convey my feelings to you.

It is true that all of our places need help. However we must also take into consideration as to where an individual could be most effective in serving the people of God and the Province. Each one of us has special talents for working with different groups of people. I believe that these talents should be taken into consideration in our assignments. I believe that I can best serve the Province in the Northwest. Given my background and the group of people that I could best work with, I believe that I would be most effective there in spreading the message of Francis.

I do understand that you want us to get new experiences and that you are a little hesitant to send us back to the place where we did our deacon term. If I had known this before, it would have probably have influenced my choice. But St. Anthony's



at Tigard is a new exciting experience for me and a challenging one. It is a place that is filled with opportunities for a young priest to get into. It is a relatively young parish that is growing at a rapid rate and it has a lot to offer. Tigard will give me the opportunity to develop my own talents and interests that would lead me in the direction as to the type of work that I would like to do in the future. As you have allowed those in the past to pursue their interests and develop them for the future, I also ask you for that opportunity now to pursue my interests and let me have the chance to develop them for the future.



I received your letter last Friday and was most happy to hear from you. I am very pleased that my request was considered at some length. I was a little disturbed though at the tone of the letter I received from you. I got the impression that there was a little anger, or that the members were a little annoyed at me. I got the feeling that it was thought that no consideration on my part was given before my request was presented to the board. Thus I felt this response on my part was necessary to clear up some misunderstandings that may be there..

God knows that I gave this matter much consideration before going to you. There has been and there still is much prayer on my part, that God would guide me in making the right decision. I have talked with several people about it, and most of them were from Ascension. My request to you was not made blindly without much consideration before hand.

I feel that I am part of the "community" here at Ascension and I don't need to work myself in. I am able to talk freely with my brothers here.. I don't feel that I am an outsider here. I had talked with most of them about my request to the Definitorium before presenting it to you so I could get their reactions. I was encouraged to go ahead with it by most of them. In fact one of them said that it would be good if I could get out because of the atmosphere that does exist and the hindrance on the work that I could best do to serve the parish. So you see that I did take them into consideration before deciding to present my request to you.

I don't spend as much time at Tigard as your letter seems to imply. My day off is Friday and I will drop in to see them, then I will usually go and visit some friends. Vince and I may go out in the evening on Friday and that is about it. Sunday after masses I will go and visit friends, but the rest of the time I am here at Ascension. In fact I know that I spend more time here than some of the other friars do.

My request to go to Tigard was made with much consideration and most important with my concern for Vince. I can't express enough the concern I have for him and the concern that the people there have for him, that he is working too hard. He is my main concern in the request I presented to return to Tigard. I am afraid that we over estimate what he can do and that he will just work himself sick. I don't want to see anything happen to him because he has a lot to offer and I like him very much and I am concerned about him and I know that I can relieve his workload.

If I go to St. Clare's, there is much to be done with their school children and the high school students don't have any programs set up for them at all. They could really use help.

I know that you are trying your very best to make the decision that would be best for me and for the friars and their work. We have three places here that all have needs and at times I wish I could be at all three at the same time.

Fr. Remy wants someone who would be interested in home visiting and that is just not my bag. He doesn't want us involved that much in C.C.D. and that is where I see the need is. I have shared this with him many times, but he has his mind made

up that he just doesn't want us involved. I understand that he will return by September 22nd.

You have always mentioned that we should be free to speak our peace and challenge where we might disagree so that we can grow. I felt that there was some misunderstanding on the part of the Definitorium and I hope that this letter will clear some of them up. I don't want them to feel that my request is just a selfish one on my part, and that I am not trying my best where I am. I see that Vince and St. Anthony's needs help and I see that St. Clare's needs help. Both in the areas that I feel capable and interested in doing but I won't be able to pursue them here. I don't want to see any heartfeelings and misunderstandings between the board and myself.

I would like to thank you for what you have done for me and especially for your patience in reconsidering my request. Would you be able to let me know if you are considering Tigard or St. Clare's after consulting with Remy? I promise to keep it confidential and not tell anyone.

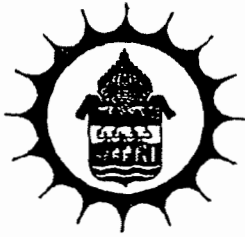

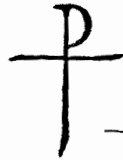

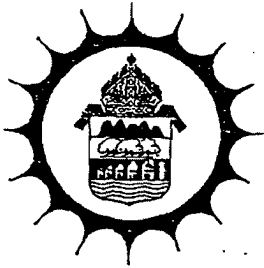

PROPOSED DOCUMENT

EXCLAUSTRATION/LEAVE OF ABSENCE DOCUMENT

In the spirit of fraternity and obedience which I have vowed, I, Gary Pacheco, have requested and accepted from the Provincial Minister of the Province of St. Barbara, according to the laws of the Church and of the Order, permission to reside outside of a religious house/ to take a leave of absence for one year beginning September 1, 1988. I understand that if I wish to extend this exclaustration/leave of absence beyond one year, I must request permission of the Minister General, in writing, giving my reasons. (Cn 686,1; GS 213,1) The Minister General may grant permission for three years; beyond these four years, I must petition the Holy See. (Cf. 686,1; GS 213,1)

I understand that by the provisions of the laws of the Church and of the Order, while I am on leave of absence my active and passive voice are suspended; also, that by reason of certain actions, e.g. attempted marriage, all obligations of the Order and Province may be voided. (Cn 694, 1; GC 258)

The Province agrees during my leave of absence to provide me with coverage under the policy of health care, unless and until I get a job which covers this.

I assume responsibility for any civil and pastoral obligations, for any debts, expenses and other obligations, incurred by me during my leave of absence, and I discharge the Province from any and all liability for such debts, obligations, etc.

I acknowledge that I have in my possession all of my personal property and personal effects, and I hereby release and discharge the Province from any and all liability for any such items.

I understand that if I do not have the usual arrangement for processing my income through the Provincial Office, I am required by law to pay income tax.

I agree to be solely responsible for the filing of all federal, state and local tax forms and to pay such taxes.

The terms of this agreement are in the nature of a true contract. I have read and fully understand the provisions thereof.
