



Judge: Reagan 'Subject To Call' In North's Trial

The Associated Frees WASHINGTON

WASHINGTON — Oliver North's Iran-Contra trial will begin Thesaday with President Bush free of a subpoens seeking his testimony but with former President Reagan still "subject to call," the judge in the case said Monday.

Portions of Reagan's diary also might be required as evidence, U.S. District Judge Gerhard Gesell ruled. However, he rejected North's subpoens seeking Bush's testimony in the trial in which North faces 12 criminal charges.

inst March, walks into the U.S. courthouse near the foot of Capitol Hill, he
will become the first figure in the
Iran-Contra affair to stand trial.

Many of the same witnesses
who testified in the nationally televised congressional hearings two
