Cardinal Sean P. O'Malley omitted the names of 70 religious order and visiting clerics from an official list of publicly accused sexual abusers that the Boston Archdiocese published in August. Among those left off O'Malley's list are several well-known abusive priests who have been sentenced to prison.

To compile this list, the Globe reviewed archdiocesan records, court documents, material published by the Globe and the Associated Press, as well as information provided by plaintiff attorneys, and the website BishopAccountability.org. The Globe included priests and other clerics who faced at least one unresolved allegation of sexual abuse in the Boston Archdiocese against someone under age 18, even if the accusation did not result in a lawsuit or settlement.
