The Archdiocese of Phila.,through counsel Welsh & Recker, P.C. is ordered to forthwith collect and make ready for production no later than March 26, 2012, in the event the Court orders in camera review or disclosure, all records within the custody or control of the Archdiocese of Phila., or its prior or current counsel, containing allorney-client communications between defendant William Lynne and counsel during the period of 1/1/91 until 2/10/11, the date of his arrest on the present charges, to the extent those communications related to the sexual abuse of minors or are related in any way to thte possession or viewing of child pronography by a priest.
- 2. For the purpose of this order, "attorney-client" communications include--
- a. Oral, written, electronic or other communications conveying statements, thoughts, opinions, advise, or other information of any kind to counsel from Monsignor Lynn or from counsel to Monsignor Lynn;
- b. Documents or electronic communications not authored by Mon.Lynn or addressed to someone other than Monsignor Lynn, if copies of such documents or electornic communications contain statements, thoughts, opionion, advisce, or other information of any kind provided to counsel or received from counsel and (1) show on their face that they were routed to or otherwise provided to Monsignor Lynn or the Office of Clergy, or (2) are otherwise procided to Monsignor Lynn or the Office of Clergy;
- c. Documents which include summaries, recitations, notes, or discussios of oral, written, electornic, or other communications described in paragraph 2a or 2b; and
- d. All records previously withheld from the Commonwealth in response to grand jury and other subpoenas based on an assertion of attorney-client privilege.
